Dear Exhibitor Partner,

It seems like just last week we were cleaning up the Fairgrounds after another great fair. A quarter of 2017 has passed, and we on the Fair Board are preparing for summer. Summer in Indiana means county fairs – and the 2017 Boone County 4-H Fair will be upon us in just a few months.

Exhibitors, such as you, are of tremendous importance to our fair. Monies raised from our space leases support the fairgrounds, and our many young students involved in the 4-H program. Boone County has one of the finest 4-H facilities and programs in the state. We believe our fair offers an outstanding value for our business partners, and we hope you will look to again share your products and services with the community as an exhibitor.

This year's fair dates are **July 22 – 28**, meaning **it starts on a Saturday and not a Friday**. This does shift the commercial building schedule slightly. The hours the commercial building will be opened this year are as follows: Saturday, July 22 – 2 PM to 10 PM; Sunday, July 23 – Noon to 9 PM; Monday through Wednesday 5 PM to 9 PM each night. The commercial exhibits need to be removed after 9 PM on Wednesday. **This year there will be another event held first thing Thursday morning in the building so all exhibitors must load out Wednesday night.**

We have a commercial building that offers 3 space sizes, and the ability to hook together adjacent spots to create the layout that best showcases your offerings. There are spaces along the outside walls (these are 8X10 spaces) that allow the exhibitor to use the wall for display, and spaces in the aisle (these are 10X10 spaces & limited 10X16 space) for free standing booths. In addition, there are a number of areas around the grounds itself that are conducive to set ups – and we offer a tent rental program as well – we take care of the hassle, you get a great spot and tent!

All returning exhibitors are given the opportunity to retain the same space as the prior year if we receive your contract by May 15th. If you would like to re-locate your space, you will be given top priority for new spots as they open.

We hope to hear from you soon, and we look forward to again partnering with you for a successful 2017 Boone County 4-H Fair.
